CHWCC, a division of Catholic Healthcare West, owns and operates four acute care facilities including Marian Medical Center (Santa Maria), St. Francis Medical Center (Santa Barbara), St. Johns Regional Medical Center (Oxnard), and St. John's Pleasant Valley Hospital (Camarillo). Total bed capacity for the region is 774 including general acute care, skilled nursing, and geri-psychiatric units. Marian Medical Center (Santa Maria) is a full service, 130-bed acute care hospital and a 95-bed extended care center including sub-acute, transitional and rehabilitative care. A children's day care center is provided on-site. Other community services include home care/hospice, infusion services, industrial medicine and two community health clinics. St. Francis Medical Center (Santa Barbara), an 84-bed facility provides a variety of inpatient, outpatient, and community outreach services. In addition, it has a 21-bed transitional and residential care assisted living facility.

- Directed the overall operations of the region's four facilities including community clinics, ambulatory services, home care and outreach programs with over 3000 employees and net revenues in excess of \$300 million. Direct reports include three hospital presidents, chief financial officer, chief medical officer, chief information officer, and the VP for business development.

MHVC was a regional system comprised of St. John's Regional Medical Center and St. John's Pleasant Valley Hospital. It was merged into CHWCC in 1997. SJRMC is a 264-bed acute care hospital in Oxnard, providing a broad range of primary and secondary services as well as tertiary care including oncology, cardiovascular, and acute rehabilitation. In addition it includes extensive ambulatory and community-based programs. SJPVH was acquired in 1993. Located in Camarillo, it combines an 81-bed acute care hospital and a 99-bed skilled nursing facility, offering comprehensive medical and surgical services, physical therapy, hyperbaric medicine, and women's services. Senior programs include long-term rehabilitation and transitional care.

- Directed the merger of the two facilities forming one governing body, management team and medical staff. Improved net income by over \$3 million in three years.
